- HB 1215** As introduced, this bill seeks to prohibit clinics from covering the costs of paying essential workers, such as nurses and social workers, by eliminating charges known as facility fees. These charges cover costs directly related to providing care. The amended bill approved by the committee would still prohibit the charges for patients receiving primary and preventive care services, and when patients access medical services via telehealth. As a result, the bill remains extremely problematic.
- HB 1243** Supportive Education for Research: Clinical partners and their support for research, education, and training programs at the school are important – this bill would eliminate them. Their support for these programs have allowed us to provide advanced life-saving care through clinical trials, to open a branch campus in Colorado Springs, and to expand the number of resident physicians we train. We are asking state lawmakers to allow their important contributions to continue to count as community benefit contributions, just as the federal authorities allow.
