Marilyn E. Coors is Associate Professor Emerita of Bioethics at the Center for Bioethics and Humanities at the University of Colorado Anschutz Medical Campus for over twenty years. The ethical issues in clinical and behavioral genomic research were the foci of her research, teaching, and professional service.

Research interests pursued by Dr. Coors include the ethics of human genetic modification, ethical issues in genomic research in adolescents with substance use disorder and their parents, and community based participatory research on informed consent for biobanking. As the Director of Research Ethics for the Colorado Clinical and Translational Science Institute, she was directly involved in research ethics consultation and cross disciplinary ethics education. Coors was an Affiliate member of Colorado University Division of Substance Dependence, and Affiliate Faculty of the Division of Biomedical Informatics and Personalized Medicine, and a Faculty Fellow of Colorado University Institute of Behavioral Genetics.

Dr. Coors received her undergraduate education from Cornell University where she majored in biological sciences. She then attended the University of Denver, earning a M.S. in cytogenetics, a M.A. in ethics and religion, and a Ph.D. in bioethics. Coors serves on the Gates Institute for Regenerative Medicine Advisory Board, the National Catholic Bioethics Center, and Educating on the Nature and Dignity of Women (ENDOW) Boards of Directors.
