**Questions and Answers** 

1. The specs call for owner stock, but it says to refer to 01-78-46. I did not see that attached to the specs submitted. Can you tell me what the amount of owner stock will be? *Answer* – 100 sq. ft. of full-size units for each type indicated.

2. Spec Section 09 68 13 – Tile carpeting: Does CU Anschutz require a specific manufacturer/model of the carpet tile for this project? If so, can that be provided? Or are all manufacturers acceptable, such that they meet the rest of the Spec Section?

Answer – Yes, all Manufactures / model of CPT are acceptable if the specs are met.

3. Is new base (rubber, tile, wood, etc.) required for all areas receiving carpet? If so, please provide spec.

Answer – Yes, Base with 4" rolled product.

  - 1. Manufacturers: Subject to compliance with requirements, provide products by one of the following:
    - a. Johnsonite.
    - b. Musson, R.C. Rubber Co.
    - c. Roppe Corporation, USA.
  - 2. Material Requirement: Rubber.

  - 4. Minimum Thickness: 0.125 inch.
  - 5. Height: 4 inches.
  - 6. Lengths: Coils in manufacturer's standard lengths.
  - 7. Outside Corners: Preformed.

4. Spec Section 09 91 23 – Int Painting: Does CU Anschutz require a specific

manufacturer/color of the paint for this project? If so, please provide.

*Answer* – All manufactures of paint are acceptable if the specs are met. No owner stock is required.

a. During site walk it was mentioned that a single color will be used for ALL painting. Please confirm.

Answer – yes, a single color will be used.

- Several offices/locations in wing have wood trim. Is this trim to be painted or taped/covered/protected.
   Answer – Taped/covered/protected.
- 1. Bid Form Is there specific bid form that CU Anschutz requires for this project? If so, please provide.

Answer- Attached to this Addendum along with Bid Bond and Instruction to Bid.

- 2. Door/Frame demo Will that include all wall/framing/drywall associated with that opening, or just the door/frame/transom/sidelites?
  - Answer Extend the drywall hard lid to the ACT ceiling.
  - a. If complete wall removal, will CU require ACT transitions to be installed where wall was removed? Or a Framing/drywall bulkhead?
  - b. If a bulkhead, what shall be the AFF height of the bottom of the bulkhead?
- 3. For the purposes of furniture storage during work, will the entire wing be unoccupied, so that furniture may be stored/clustered together, or will contractor be required to provide Containers/Connex's to store? If storage in Connex's, please provide location on campus for Connex staging.

Answer – The area will not be occupied; Access must be provided for life safety.

 Will CU require the installation of Expansion Joints in the drywall of the walls prior to painting? If so, please provide desired spacing.
 Answer – Expansion joints will be provided where the frames are removed. No other

will be required. May be discussed after contractor selection.

- Furniture removal Will the filing cabinets be emptied of all CU work/files prior to contractor beginning project? *Answer*- No, they will not be emptied. May be discussed after contractor selection.
- 6. What is CU's requirement for attic stock on this project? Answer – See Question # 1
- Please confirm the total number of pictures that will need to be removed and rehung. *Answer* – Not possible currently. All pictures will have to go back at the same location. However, room signage will be removed and reinstalled.
- 8. Please provide a phasing plan for the carpet removal and replacement. *Answer* – Attached to this Addendum
- 9. Please advise if a bulkhead is to remain above the (2) removed doors. Answer – See Questions # 6
- 10. Would you like to replace the base at the same time the carpet is being replaced? *Answer* yes See question # 3

11. Can we create a small bulkhead to be finished to match the adjacent walls and ceilings where the two doorways are to be removed? *Answer* – See answer # 6

Each bidder is required to bid on all alternates and indicate the time from the date of the Notice to Proceed to Substantial Completion in calendar days, and in addition, the bidder is required to indicate the period of time to finally complete the project from Substantial Completion to Final Acceptance, also in calendar days. - 2. **INCONSISTENCIES AND OMISSIONS:** Bidders may request clarification of any seeming inconsistencies, or matters seeming to require explanation, in the bidding documents at least three (3) business days prior to the time set for the opening of Bids. Decisions of major importance on such matters will be issued in the form of addendum.
- 3. **APPLICABLE LAWS AND REGULATIONS:** The bidder's attention is called to the fact that all work under this Contract shall comply with the provisions of all state and local laws, approved state building codes, ordinances and regulations which might in any manner affect the work to be done or those to be employed in or about the work. Attention is also called to the fact that the use of labor for work shall be governed by the provisions of Colorado law which are hereinafter set forth in Articles 27 and 52E of the GENERAL CONDITIONS.
- 4. UNAUTHORIZED IMMIGRANTS: Note that the Special Provisions of the General Conditions of the Contract includes the following language: PUBLIC CONTRACTS FOR SERVICES CRS 8-17.5-101 and PUBLIC CONTRACTS WITH NATURAL PERSONS 24-76.5-101.
